BOOTH FEES

All booths are 10' X 10' spaces and are rented at the full season (23 weeks) rate of \$400 per booth, or \$225 for a half season (12 weeks). There are also \$50 farmer's season (5 weeks) spaces that are available for local farmer's produce ONLY. All approved vendors must submit payment prior to participation in the market. Space assignments are issued by the Farmers Market Coordinator upon application approval. Booth fees are non-refundable.

ATTENDANCE DEPOSIT

The market requires a \$100 deposit from every vendor to ensure consistent attendance. Deposits are payable via check or credit card to Callaway Gardens Resort, Inc. If your application is approved, the \$100 deposit will be returned in full within 30 days of the close of the Farmers Market provided the vendor participates in 80% of the selected Farmers Market season. If your application is not accepted, the deposit will be returned in full.

HOLD HARMLESS/INDEMNIFICATION/COPYRIGHT AGREEMENT

The vendor shall indemnify and hold harmless Callaway Gardens Resort Inc. from and against any and all liability, claims, demands, damages, expenses, fees, fines, penalties, suits, proceedings, actions and costs of actions, including attorney's fees for trial and on appeal, of any kind or nature arising out of or in any way connected with this contract or the vendor's use of the space(s), sale of goods or conduct of business by the vendor, its agents, servants, employees, customers, patrons or invitees or any act or omission of the vendor, its agents, servants, employees, customers, patrons or invitees.

The vendor is responsible for all monies collected from the sale of the vendor's goods, as well as collecting and reporting of sales tax. Callaway Gardens Resort, Inc. is in no way responsible for any lost or stolen monies or items.

The vendor assumes all costs arising from the use of patented, trademarked or copyrighted materials, equipment, devices, processes, or dramatic rights used on or incorporated in the conduct of any vendor at or related to its operations at the Farmers Market; and the vendor agrees to indemnify and hold harmless Callaway Gardens Resort, Inc. from all damages, costs and expenses in law or equity for or on account of any patented, trademarked or copyrighted materials, equipment, devices, processes, or dramatic rights furnished or used by the vendor in connection with this agreement and will defend Callaway Gardens Resort, Inc. from any such suit or action, regardless of whether it be groundless or fraudulent.

By submitting this application, the vendor acknowledges this application does not automatically reserve a space but is pending review by the Farmers Market Coordinator to see if items for sale fit the market criteria. If approved, the vendor will be notified of acceptance or placed on a waiting list based on space availability within a product category. Callaway Gardens Resort, Inc. reserves the right to deny any vendors who do not meet our standards and dress codes. This will be determined on a case-by-case basis. Callaway Gardens Resort, Inc. has the authority to cancel this agreement at any time.
