I/we, the undersigned, am participating in following Callaway Gardens activities at my own risk, which I voluntarily assume: **TREETOP ADVENTURE, AQUA ISLAND, PADDLE BOATS, ALL WATER SPORTS AND WATER SKIING LESSONS, OUTDOOR TRAPEZE ADVENTURE, ADVENTURE CHALLENGE ROPES COURSE, CANOE, KAYAK, AND BICYCLES.** In consideration of the fee paid by me, and in full recognition of the risks involved with such equipment and structure, which risks I voluntarily assume, I, the undersigned, hereby release Callaway Gardens Resort, Inc. and The Ida Cason Callaway Foundation™, and their agents, servants, and employees, officers and directors and agree to hold them harmless from any and all liability, claims, damages, actions, and causes of action whatsoever, for loss, damage, or injury to person, including death, and whether sustained by myself, my spouse, my parents, my child or children, or property, regardless of how arising, and however caused including but not limited to all kinds and degrees or extent of negligence (except willful or wanton negligence or misconduct) which Callaway Gardens Resort, Inc., The Ida Cason Callaway Foundation, and/or its employees may commit or be charged with, whether consisting of omission or commission, whether separately or concurrently with someone else, and sustained by me, or us, my spouse, my parents, my child or children, in connection, directly or indirectly, with the use of the recreational equipment. This release shall be binding upon me, my heirs, next of kin, and legal representative. I further agree that I am personally liable and responsible for paying any claims which may arise as a result of participation in Callaway Gardens activities, including, but not limited to any claims for personal injury, any claims for property damage to any equipment or to other property, any claims for loss of equipment or loss of use of any equipment, any claims for diminution in value of any equipment, any claims for the cost of repairing or replacing any equipment or any other claims of any kind or nature which may arise from the use of any equipment while in my possession. I further authorize Callaway Gardens Resort, Inc. to bill any such charges or costs to my credit card or to my account as Callaway Gardens Resort, Inc. deems appropriate. I further acknowledge that I have been given the opportunity to participate in these activities and that I have been advised that I can decline to participate in these activities if I wish. I am not now, nor will I be under the influence of any alcohol or any chemical substance during the activities. I understand that this agreement shall be binding upon my heirs, executors, administrators, and assigns and shall be governed by the applicable laws of the state of Georgia. I also understand that if any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect. I agree that any claims that I may bring against Callaway Gardens Resort, Inc. or The Ida Cason Callaway Foundation, Inc. shall be submitted to the jurisdiction of the courts of Harris County, Georgia and that no claims against Callaway Gardens Resort, Inc. or The Ida Cason Callaway Foundation, Inc. shall be brought in any other jurisdiction. I agree that there have been no warranties, expressed or implied, which have been made to me, which extend beyond the description of the equipment listed on this form. I acknowledge activities are unguided, and I will participate in any mandatory safety briefing session prior to the start of the course. Should I prove unwilling or unable to follow the safety rules while undertaking Callaway Gardens' activities, I acknowledge that Callaway Gardens has the right to and may immediately end my participation in any of the activities. I acknowledge that I am required to wear approved safety equipment while participating in Callaway Gardens' activities. I am aware that guides or instructors are available to answer any questions that I may have as to proper use of the equipment. I am aware that the physical exertion required for Callaway Gardens' activities and the forces exerted on the body can activate or aggravate pre-existing physical injuries, conditions, or congenital defects. I acknowledge that the level of participation is at all times completely up to the individual. I am aware that once I have completed the safety briefing session, no refunds will be made for Callaway Gardens' activities or admission to Callaway Gardens, including passes for future use. Each guest or an authorized guardian for children under 18 years of age must complete a Callaway Gardens Release of Liability form before starting Callaway Gardens' activities. Obscene language is not permitted. Anyone who appears to be under the influence of drugs or alcohol may not participate in the Callaway Gardens activities. Callaway Gardens reserves the right to remove anyone who disregards the safety rules or who appears to be unable to safely complete the course. There will be no refunds if such action is required. ### IMPORTANT INFORMATION

#### TreeTop Adventure (Discovery and Lake Course)

- Participants must be at least 54" tall and successfully complete a TreeTop Adventure briefing session before use of the course.
- Max waist size for harnesses 48"; max thigh size 26".
- Closed-toe secured footwear is required (no sandals, flip-flops, crocs, slippers, etc.).
- Pregnant women are prohibited from going on the TreeTop Adventure course.
- Callaway Gardens reserves the right to close TreeTop Adventure at any time due to inclement weather deemed unsafe for guests.
- Cell phones are prohibited on the TreeTop Adventure course. Please make appropriate arrangements for these and other personal items before entering the course. Callaway Gardens may not be held responsible for lost or damaged personal items.

#### TreeTop Adventure (Sapling Course)

- Participants must be at least 36" to 60" tall and successfully complete a TreeTop Adventure briefing session before use of the course.
- Closed-toe secured footwear is required (no sandals, flip-flops, crocs, slippers, etc.).
- Callaway Gardens reserves the right to close TreeTop Adventure at any time due to inclement weather deemed unsafe for guests.
- Cell phones are prohibited on the TreeTop Adventure course. Please make appropriate arrangements for these and other personal items before entering the course. Callaway Gardens may not be held responsible for lost or damaged personal items.

#### Aqua Island

- Guests must wear a Personal Flotation Device (PFD) and keep it buckled and zipped at all times.
- Each guest or an authorized guardian for children under 18 years of age must complete a Callaway Gardens Release of Liability form before starting the course.
- Sharp objects or other dangerous materials are not permitted.
- Tobacco and alcohol are not permitted in the briefing areas for Aqua Island.
- Pregnant women are prohibited from going on Aqua Island.
- Callaway Gardens reserves the right to close Aqua Island at any time due to inclement weather deemed unsafe for guests.
- Cell phones are prohibited on the Aqua Island. Please make appropriate arrangements for these and other personal items before entering the course. Callaway Gardens may not be held responsible for lost or damaged personal items.

#### Paddle & Bumper Boats

- Participants must be at least 54" tall to operate a boat alone.
- Guests must wear a Personal Flotation Device (PFD) and keep it buckled and zipped at all times.
- Each guest or an authorized guardian for children under 18 years of age must complete a Callaway Gardens Release of Liability form before starting the course.
- Sharp objects or other dangerous materials are not permitted.
- Tobacco and alcohol are not permitted in the briefing area or on Paddle Boats.
- Swimming in Chickadee Lake is not permitted.
- Boats should not be bumped.
- Please do not bring food or drinks, including glass and other breakable items on the boat.
- Boats are not allowed under the bridge or past buoy lines.
- Callaway Gardens reserves the right to close Paddle Boats at any time due to inclement weather deemed unsafe for guests.

#### All Water Sports and Water Skiing Lessons

- Guests must wear a Personal Flotation Device (PFD) and keep it buckled and zipped at all times.
- Each guest or an authorized guardian for children under 18 years of age must complete a Callaway Gardens Release of Liability form before starting the course.
- Sharp objects or other dangerous materials are not permitted.
- Pregnant women are prohibited from participating in Water Skiing and Water Skiing Lessons.

#### All Water Sports and Water Skiing Lessons (continued)

- Callaway Gardens reserves the right to close Water Skiing and Water Skiing Lessons at any time due to inclement weather deemed unsafe for guests.
- Cell phones are prohibited on the Water Skiing and Water Skiing Lessons. Please make appropriate arrangements for these and other personal items before entering the course. Callaway Gardens may not be held responsible for lost or damaged personal items.

#### Outdoor Trapeze Adventure

- Pregnant women are prohibited from going on the Outdoor Trapeze Adventure.
- Each guest or an authorized guardian for children under 18 years of age must complete a Callaway Gardens Release of Liability form before starting the course.
- Sharp objects or other dangerous materials are not permitted.
- Callaway Gardens reserves the right to close Trapeze Adventure at any time due to inclement weather deemed unsafe for guests.
- Callaway Gardens may not be held responsible for lost or damaged personal items.

#### Adventure Challenge Ropes Course

- Participants must be at least 54" tall and successfully complete Adventure Challenge Ropes Course briefing session before every use of the course.
- Closed-toe secured footwear is required (no sandals, flip-flops, crocs, slippers, etc.).
- Pregnant women are prohibited from going on the Adventure Challenge Ropes Course.
- Callaway Gardens reserves the right to close Adventure Challenge Ropes Course at any time due to inclement weather deemed unsafe for guests.
- Callaway Gardens may not be held responsible for lost or damaged personal items.

#### Canoe, Kayak or Jon Boat

- Participants must be at least 54" tall to operate a boat alone.
- Guests must wear a Personal Flotation Device (PFD) and keep it buckled and zipped at all times.
- Each guest or an authorized guardian for children under 18 years of age must complete a Callaway Gardens Release of Liability form before starting the course.
- Swimming in Mountain Creek Lake is not permitted.
- Boats should not be bumped.
- Please do not bring food or drinks, including glass and other breakable items on the boat.
- Callaway Gardens reserves the right to close Canoe, Kayak or Jon Boat operations at any time due to inclement weather deemed unsafe for guests.
- Callaway Gardens may not be held responsible for lost or damaged personal items.

#### Bicycles

- Guests must wear an approved helmet and keep it buckled at all times.
- Each guest or an authorized guardian for children under 18 years of age must complete a Callaway Gardens Release of Liability form before starting the course.
- Callaway Gardens reserves the right to close Bicycles at any time due to inclement weather deemed unsafe for guests.
- Callaway Gardens may not be held responsible for lost or damaged personal items.
